SALE TERMS AND CONDITIONS

As a consignor to this auction, I agree to the following:

A certificate of registry, or a signed batch transfer, for each animal will be supplied by me to the sale manager, along with permission for Gilchrist Auction to transfer these animals to the buyer through RAAA office in Denton, TX.

All animals must be eligible for interstate shipment. Interstate health papers prepared by an accredited veterinarian will be supplied by me to the sale manager on each animal sold and will include pregnancy status on females selling as bred. All health certificates to be turned into the office of the sale manager at least 24 hours prior to the auction.

All animals or embryo/genetic lots that are catalogued and do not arrive at the auction will be assessed sale fees. I agree to pay this commission on any animal or embryo/flush lots consigned by me that do not arrive and sell in this auction.

All animals will sell with a guarantee by the seller as outlined in the Red Angus Association of America Code of Ethical Sale Practices. It is to be clearly understood that all warranties, guarantees and refunds on any animals not meeting the standards of the RAAA Rules and Regs shall be made by the seller to the buyer upon proof of cattle not meeting their representations in the auction.

All persons who attend the sale do so at their own risk. The seller, auction facility, and sale manager assume no liability for any accidents that may occur. Neither does the seller, auction facility or sale manager assume any liability for loss or injury to livestock due to theft, mysterious disappearance, sickness, improper handling or Act of God. It is to be clearly understood that the sale manager and its representatives act only as a medium between the buyer and seller. They are not responsible in any way for the failure on the part of the buyer or seller to live up to his obligations or for the truth of any warranties or representation, express or implied. Neither does the sale manager assume any financial obligations to collect or enforce collection of monies between parties. Any legal action, that may in exceptional cases be taken, must be between the buyer and seller.

The above terms and conditions of sale shall constitute a contract between the buyer and seller of each animal and shall be equally binding upon both. Each sale or resale of an animal constitutes a separate transaction.
